NOTE: Republican candidates for Congress in Iowa's Fourth District are required to collect signatures from eligible voters in 20 counties totaling 1874 signatures in order to gain ballot access.

ISSUES WITH NOMINATION PAPERS

RANDY FEENSTRA

Systemic:

- 1. Three of Feenstra's campaign workers circulating nomination petitions for the campaign listed Feenstra's home as their address in the circulator box. Emily Schwickerath, Josh Perschall, and Matthew Leopold listed 641 2nd St, Hull, IA 51239 as their address on almost all of their nomination petitions. Yet, Leopold and Schwickerath are registered to vote in Dallas County, and on one nomination petition for Chickasaw County, Schwickerath listed her address as 2689 NW 165th Ln, Clive, IA 50325, and on a nomination paper for Palo Alto County, Leopold listed the same address in Clive. Iowa Code 2020, §43.14(1)g, §45.5(1)f call for circulators their address and not just any address. If this objection is to be approved, Feenstra would qualify in two counties (18 below the minimum). If this objection is rejected, the address box means little and any circulator may list 1600 Pennsylvania Ave, Washington, DC as their address.
- 2. Feenstra filed with the FEC as "Randall Feenstra" yet submitted an affidavit of candidacy and nomination papers listing his name as "Randy Feenstra". The name "Randy Feenstra" is listed on almost every nomination paper he submitted (excluding Feenstra Sioux) and if this objection is approved, he would qualify for the ballot in 0 counties (20 below the minimum). If there is no strict attention paid to matching names, an individual could file with the FEC as "George Smith", submit an affidavit as "Jerry Smith", and collect signatures as "James Smith" and still qualify for the ballot. Take another hypothetical: if two candidates—John Doe and John Doe—are facing off in an election and it is decided that the second John Doe must include his middle initial for the purposes of clarity, can the second John Doe still collect signatures without his middle initial?
- 3. Following recent issues in Iowa electoral history, a circulator box was added to each nomination petition sheet to prevent fraudulent collection. The intent of this law was for the circulator to have witnessed the signatures being made and be able to report to the panel that the signatures were legitimate. Schwickerath and Perschall signed that they circulated petitions that ended up collecting 793 signatures on February 3, 2020 from 20 different counties. The date is notable as it was the date of the Iowa caucuses when many campaigns distribute their nomination petitions to caucus locations without members of the campaign necessarily being present. According to the Feenstra campaign's social media pages, Schwickerath attended caucuses in Boone County and Perschall attended the Webster County caucus. However, it is physically impossible to be present in dozens of caucus locations necessary to collect 793 signatures at once. Instead, a different individual witnessed the signatures being made at the beginning of caucus, and Schwickerath and Perschall added their names after the fact without circulating the petition. If this objection is to be approved, Feenstra would qualify in 16 counties (4

below the minimum) assuming that Schwickerath testifies that she witnessed the Boone County signatures being made. If this objection is rejected, the circulator box is meaningless, these important recent reforms have no enforcement measurement, and election security in the state of Iowa is nothing but an open door.

• CLAY – The required number of signatures in Clay County for a Republican to qualify for the ballot is 88. Feenstra filed 94 (six signatures over the required minimum). However, within this count include 7 duplicate signatures, 4 voters from other counties who signed for Clay County, and 6 unidentifiable persons.

STEVE KING

Systemic:

1. As stated previously, following recent issues in Iowa electoral history, a circulator box was added to each nomination petition sheet to prevent fraudulent collection. The intent of this law was for the circulator to have witnessed the signatures being made and be able to report to the panel that the signatures were legitimate. Jeff King signed that he had personally collected 2,846 signatures on February 3, 2020 from 36 different counties. The date is notable as it was the date of the Iowa caucuses when many campaigns distribute their nomination petitions to caucus locations without members of the campaign necessarily being present. According to records from caucus night, Jeff King was present at the Sac County caucus in order to be elected a county delegate. Moreover, it is physically impossible to be present in over 100 caucus locations necessary to collect 2,846 signatures at once. Instead, a different individual witnessed the signatures being made at the beginning of caucus, and Jeff King typed his name into the circulator box without circulating the petition. If this objection is to be approved, Steve King would qualify in 1 county (19 below the minimum) assuming that Jeff King testifies that he witnessed the Sac County signatures being made. If this objection is rejected, the circulator box is meaningless, these important recent reforms have no enforcement measurement, and election security in the state of Iowa is nothing but an open door.

BRET A RICHARDS

Systemic:

1. As stated just before, following recent issues in Iowa electoral history, a circulator box was added to each nomination petition sheet to prevent fraudulent collection. The intent of this law was for the circulator to have witnessed the signatures being made and be able to report to the panel that the signatures were legitimate. Brett Barbin signed that he had personally collected 214 signatures on February 3, 2020 from 12 different counties. The date is notable as it was the date of the Iowa caucuses when many campaigns distribute their nomination petitions to caucus locations without members of the campaign necessarily being present. According to records provided from caucus night, Barbin was present at the Crawford County Southeast Precinct Caucus in order to be elected a delegate. However, it is impossible to be present in over a dozen caucus locations across the Fourth District necessary to collect 214 signatures at once. Instead, a different individual witnessed the signatures being made at the beginning of caucus, and Barbin wrote his name into the circulator box without circulating the petition. If this objection is to be approved, Richards would qualify in 33 counties (13 above the minimum). If this objection is rejected, the circulator box is meaningless, these important recent reforms have no enforcement measurement, and election security in the state of Iowa is nothing but an open door.

JEREMY TAYLOR

Systemic:

- 1. On January 24, 2020, Woodbury County Auditor Pat Gill found that Jeremy Taylor ceased residing at 3215 Grandview Blvd, Sioux City, IA after purchasing a home at 5202 Christy Road, Sioux City, IA in May of 2019. Taylor's voter registration at Grandview was subsequently revoked after this discovery. Iowa Code 2020, §43.14 calls for circulators to note "the printed name, signature, address, and phone number of the person responsible for circulating the petition page". Following this decision in late January 2020, Taylor began writing the Christy Road address as his own in the circulator box. Yet, between the months of June 2019 and January 2020—the months during which he was found not to reside at Grandview—Taylor used the Grandview address for the circulator box on every petition page. During the proceedings before Gill, Taylor affirmed that his wife, Kim, and the rest of his family resided at Christy Road starting in June 2019. Along with her husband, Kim Taylor circulated a number of sheets and listed her address at Grandview between June 2019 and January 2020 as well. If this objection to the Taylors' residency is approved, Taylor would qualify in 14 counties (six below the minimum). If this objection is rejected, the panel believes residency is not a requirement to be one's address.
- 2. Iowa Code 2020, §43.14 calls for circulators to note "the printed name, signature, address, and *phone number* of the person responsible for circulating the petition page". On a number of nomination papers, Taylor neglected to list his phone number.

3. As stated previously, following recent issues in Iowa electoral history, a circulator box was added to each nomination petition sheet to prevent fraudulent collection. The intent of this law was for the circulator to have witnessed the signatures being made and be able to report to the panel that the signatures were legitimate. Blake Jackson, Jeremy Taylor, and Kim Taylor signed that they circulated petitions on February 3, 2020 that ended up collecting 458 signatures from 17 different counties. The date is notable as it was the date of the Iowa caucuses when many campaigns distribute their nomination petitions to caucus locations without members of the campaign necessarily being present. According to the Taylor campaign's social media pages as well as records from caucus night, all three persons attended caucuses in Woodbury County in order to vote and run for county delegate. However, it is physically impossible to be present in dozens of caucus locations across the district necessary to collect 458 signatures at once. Instead, a different individual witnessed the signatures being made at the beginning of caucus, and Jackson and the Taylors added their names after the fact without circulating the petition. If this objection is to be approved, Taylor would qualify in 22 counties (2 above the minimum). If this objection is rejected, the circulator box is meaningless, these important recent reforms have no enforcement measurement, and election security in the state of Iowa is nothing but an open door.

County specific:

• HARRISON – The required number of signatures in Harrison County for a Republican to qualify for the ballot is 79. Taylor filed 83 (four signatures over the required minimum). However, within this count include 6 duplicate signatures, 1 signature from a voter residing outside of Harrison County, 1 unidentifiable person, and a sheet with an incorrectly filled out candidate box.

Incorrect form

1. On the sheet titled Taylor Harrison 8, *both* answers to the question "Is the candidate running to fill a vacancy due to death, resignation, or temporary appointment of an office holder?" are checked. Although only "No" is checked on almost all other petitions, this form would have misled voters to believe that Taylor, in this particular case, was running in a special election to fill the seat after Congressman King had died or resigned from Congress. The 2020 Candidate's Guide to the Primary Election states that when the "yes" box is checked, the "candidate is running to fill the remainder of an unexpired term" (2020 Candidate's Guide to the Primary Election, 4). This is not the case in Taylor's election.

If these objections are approved, Taylor would lose 15 signatures from Harrison County and fall short of the threshold by 11 signatures. If this second objection is rejected, it should be made known that this question need not be answered correctly.

 AUDUBON – The required number of signatures in Audubon County for a Republican to qualify for the ballot is 34. Taylor filed 44. 10 signatures over the required minimum.
However, within this count include 1 duplicate signature and an invalid sheet containing a different candidate name than was written on Taylor's affidavit of candidacy.

Incorrect form

1. On the sheet titled Taylor Audubon 1, a different candidate name than that which is written on Taylor's affidavit of candidacy is included. According to the Secretary of State's 2020 Candidate's Guide to the Primary Election as well as Iowa Code 2020, §43.14(1)b, §45.5(1)b, the candidate's name must be included on every nomination paper and "printed *exactly* as the candidate wishes the name to appear on the ballot" (2020 Candidate's Guide to the Primary Election, 6). Similarly, the name that appears on the affidavit "must be printed *exactly* as the candidate wishes the name to appear on the ballot" (2020 Candidate's Guide to the Primary Election, 4). Transitively speaking, no variation between affidavit and nomination papers beyond what the candidate wishes the name to appear on the ballot is permitted. The Taylor

Audubon 1 sheet lists its candidate name as "Jeremy James Taylor" and should therefore count towards the filing of a candidate "Jeremy James Taylor" and not "Jeremy Taylor". If this objection is rejected, the precedent that is set is that a candidate name's on the affidavit need not match the respective nomination papers, even in the case when clarity is critical.

• CALHOUN – The required number of signatures in Calhoun County for a Republican to qualify for the ballot is 55. Taylor filed 65. 10 signatures over the required minimum. However, within this count include 4 unidentifiable persons and 3 incorrect forms.

EXAMPLES:

Unidentifiable persons

- 1. Taylor Calhoun 1, #2 is not registered at the given address.
- 2. Taylor Calhoun 1, #2 is not registered at the given address.
- 3. Taylor Calhoun 5, #1 is not registered at the given address.
- 4. Taylor Calhoun 9, #8 is not registered at the given address.

Incorrect form

- 1. Taylor Calhoun 5 lists "Jeremy James Taylor" as the candidate.
- 2. Taylor Calhoun 5 does not list a circulator phone number as required by Iowa Code 2020, §43.14(1)g, §45.5(1)f.
- 3. Taylor Calhoun 1 presents *both* answers to the question "Is the candidate running to fill a vacancy due to death, resignation, or temporary appointment of an office holder?" to signers. Although only "No" is checked on almost all other petitions, this form would have misled voters to believe that Taylor, in this particular case, was running in a special election to fill the seat after Congressman King had died or resigned from Congress.
- DICKINSON The required number of signatures in Dickinson County for a Republican to qualify for the ballot is 112. Taylor filed 156 (44 signatures over the required minimum). However, within this count include 20 duplicate signatures, 3 out of county signatures, 4 unidentifiable persons, and 4 sheets with significant circulator errors.

<u>Unidentifiable persons</u>

- 1. Taylor Dickinson 2, #9 is not registered at the given address.
- 2. Taylor Dickinson 2, #10 is not registered at the given address.
- 3. Taylor Dickinson 8, #20 is not registered at the given address.
- 4. Taylor Dickinson 17, #6 is not registered at the given address.

Incorrect form

- 1. On the sheet titled Taylor Dickinson 2, a different election date is given than the one Taylor provided on his affidavit of candidacy. According to the Secretary of State's 2020 Candidate's Guide to the Primary Election as well as Iowa Code 2020, §43.14(1)f, §45.5(1)e, the date of the election for which the candidate is nominated must be included. June 2, 2020 is the election date Taylor listed on his affidavit of candidacy, not February 22, 2020 which is included on this page.
- 2. Taylor Dickinson 6 lists the election date as February 22, 2020.
- 3. Taylor Dickinson 8 lists "Jeremy James Taylor" as the candidate.
- 4. Taylor Dickinson 17 lists the election date as February 22, 2020.
- POCAHONTAS The required number of signatures in Pocahontas County for a Republican to qualify for the ballot is 42. Taylor filed 55 (13 signatures over the required minimum). However, within this count include 5 unidentifiable persons, 1 person residing outside the jurisdiction, and 2 incorrect forms.

EXAMPLES:

Unidentifiable persons

- 1. Taylor Pocahontas 1, #2 is not registered at the given address.
- 2. Taylor Pocahontas 1, #10 is not registered at the given address.
- 3. Taylor Pocahontas 2, #1 is not registered at the given address.
- 4. Taylor Pocahontas 2, #2 is not registered at the given address.
- 5. Taylor Pocahontas 2, #7 is not registered at the given address.

Outside of Pocahontas County

1. Jamie Hanssen is registered at 310 S Oswego St, Pomeroy, IA which is in Calhoun County.

Incorrect form

- 1. Taylor Pocahontas 2 incorrectly presents the date of the election as February 25, 2020.
- 2. Taylor Pocahontas 8 incorrectly states that Taylor's residence is in Pocahontas County.

If some of these blatant violations to the intent and letter of the Iowa Code are left unenforced, it would be an affront to the voter ID and election security measures pursued by this panel's respective offices. Our elections would become lawless, seeking public office would not be granted the appropriate seriousness, and our democratic nominating process would continue unsecured.
